- (i) Request of M/s.Gland Pharma Ltd.,(Unit No.II) manufacturing anti-cancer drugs for export - for inclusion of New product in their LoA
- (ii) Ratification of the permission granted by O/o DC, VSEZ to import raw material and packing material pending approval of inclusion of the new product by UAC

The unit was issued LoA dt.26.03.2009 for manufacture of anti-cancer drugs for export. The unit commenced production w.e.f.24.04.2012 . The unit intends to add the following new product in their LoA:

The unit declared that the above products are not in the prohibited list of goods in terms of ITC(HS).

The unit has submitted process chart of manufacture of the above drug.

The unit submitted photo-copy of approval L.Dis No.HMF07-14051/410/2020-Tech-DCA dt.31.07.2020 of Drug Control Administration, Guntur.

The unit further vide their letter dt.04.09.2020 expressed urgency and requested to permit them to import raw material and packing material required for their new product before the UAC's approval to meet the manufacturing schedule timelines. The office of DC, VSEZ keeping the exigency expressed by the unit in view, dealt the request on file and accorded permission vide letter dt.10.9.2020.

The request of the unit (i) for inclusion of the new product in their existing LoA in terms of Rule 19(2) of SEZ Rules, 2006 and, (ii) the permission already granted, vide letter dt.10.09.2020 by the of O/o DC, VSEZ for import of raw material and packing material meant for the said new product is placed before UAC for considering (i) for approval and (ii) ratification respectively.
