Ltd was issued LOA No. 9/311/SEZ/HYD/2016/599/SEZ dated 16.2.2016 for setting up of a unit in an area admeasuring 4,18,133 sq. ft in multiple levels of Bar Building, Phase 2.2 & 2.3 (i.e., Tower 2 &3 of Phase 2) of WaveRock, M/s. TSI Business Parks (Hyderabad) Pvt. Ltd, IT/ITES SEZ at Nanakramguda Village, Serilingampally Mandal, Ranga Reddy District, Telangana. The unit commenced operations on 8.8.2016 and the LOA is valid upto 7.8.2021.

The unit vide its letter dated 10.8.2020 (Received on 13.8.2020) has stated that they want to expand its existing unit by taking additional area of 11,747 sq. ft. on Part D of Level-3 and 30,230 sq. ft. on Part B & C of Level-14 in Tower 2.1 of the WaveRock project in the above SEZ.

The unit has projected Exports for Rs. 28,219 Lakhs, FE Outgo for Rs. 2,834 Lakhs, NFE of Rs. 25,385 Lakhs, Employment of 235 Nos.

The Co-Developer vide letter dated 6.8.2020 has provided Letter of Intent to that effect.

M/s. Model N Software Pvt. Ltd was issued LOA No. SEZ (IT/ITES)/MNIS/DLF/(HYD)/0023/2009-10 dated 26.2.2010 for setting up of a unit and presently operating in an area of 52,224 sq. ft. in Ground, 6th and 8th Floors, Block-3, M/s. DLF Assets Pvt. Ltd, Co-Developer for M/s. DLF Info City Hyderabad Ltd, IT/ITES SEZ at Gachibowli Village, Serilingampally Mandal, Ranga Reddy District. Telangana. The unit commenced operations on 1.7.2010 and the LOA is valid upto 30.6.2025.

The unit vide its letter dated 12.8.2020 (Received on 14.8.2020) has stated that the office space at 6th Floor was not fully utilized and considering the current business scenario & future business prospects post Covid-19, their management has decided that they will not be requiring area admeasuring 15,198 sq. ft. in 6th Floor, Block-3 in the above SEZ.

The unit has also stated that post surrender of the above space, there will no revision in the NFE projections, Investment and Employment.
