Request of M/s.Worldwide Diamond and Jewellery Manufacturers Pvt.Ltd., Shed No.24, SDF-1, VSEZ, Duvvada to incorporate newly introduced ITCHS 71049020 in their existing LoA – reg.

M/s. Worldwide Diamond and Jewellery Manfuacturers Pvt.Ltd., was issued LoA on 8.11.2018 for

1. ‘Cutting / Laser cutting & polishing of **synthetic or laboratory grown diamonds** ’and to export the same under ITC HS 7104 90 10, under the **six digit ITCHS worldwide.common code, 7104 90**

2. Manufacturing Jewellery items with precious metals unstudded or studded with synthetic or Laboratory grown diamonds under ITCH 71131910, 71141110, 71131940, 71131130, 71069290

Later , a **new ITCHS 7104 20 10** has been introduced for ‘Synthetic or Laboratory grown diamonds’ under the six digit ITCHS **7104 20** common code, worldwide **under the item- heading:** unworked or simply sawn **or roughly** shaped.

In the present request of the unit, if “ Synthetic or Laboratory grown **rough diamonds**” that were imported for cutting /laser cutting and polishing are required to be returned as ‘ re-export’ for any reason, in that case, the unit needs to have the items mentioned in their LoA as per prescribed form (FORM G) and we may mention ITC HS also in their LoA.

If the request is only for import of the said rough items, it seems, there is no necessity for their inclusion in their LoA as in terms of Rules 27 of SEZ Rules. If the request is for export purpose, the same need to be mentioned in the LoA as per prescribed Form G .

We may therefore, place the request the Unit before the UAC to consider their request for incorporation of ‘Laboratory grown or synthetic **rough diamonds**’ along with its ITCHS 7104 20 10 in their LoA , to amend of the LoA accordingly, as follows:.

3. Laser cutting and polishing of Synthetic or Laboratory grown Diamonds under ITCHS 7104 90 10
