The unit represented that they were approved the service “Technical testing and analysis service” under the services availed within SEZ UNDER Notification 40. However they had availed the service outside the Zone and therefore had filed for refund. However the claim was not accepted by the service tax department as the service was approved within the SEZ, and the service was availed outside SEZ. The unit represented that they had applied for the service under both the categories and the approval was received under only one category i.e “within SEZ”. They should therefore be extended the benefit.

The Approval Committee had clarified that, under Notification 40, units/developers had the liberty to claim abenitio exemption or refund for services availed within zone and only refund for services availed outside SEZ. The services were therefore grouped into three categories with first two categories being eligible for exemption or refund, while the third category invariably should go for refund.

The services were grouped in either of the categories without repetition in different categories to avoid confusion. It was generally advised that even when a service is categorized under I & II, the unit or developer has to seek refund if the service is availed outside the SEZ. The unit's claim therefore seems to be in order.

Therefore it is clarified that unit/developer can seek abinitio exemption or refund for services approved under category I & II under Notifications 17 and 40. The unit's which have availed services approved under the above categories outside SEZ can seek refund of service tax, while services approved under category III should invariably seek refund.
