The Approval Committee after due deliberations, considered and approved the proposal for expansion of the SEZ unit in an area of 31,562 sq. ft. at 15th Floor in Tower-8 in the above SEZ. After expansion, the unit will be operational in an area of 66,643 sq. ft in the above SEZ.
